

TERMS and CONDITIONS

Stall site numbers are limited by the event area. Strict selection criteria applies.

- *Wherever possible, preference will be given to stallholders from the local region, providing they meet all the application criteria.*
- *The Goomeri Pumpkin Festival Inc committee reserves the right to refuse any stall booking. No correspondence will be entered into.*
- *Sites will be allocated by the Stall Site Co-ordinator. Stall holders **MUST** use the stall site allocated to them on festival day and site locations will not be amended unless by stall co-ordinator on the day.*
- *Stallholders and vendors who actively seek to reduce their environmental impact and consistently use sustainable environmental practices will be given higher priority*
- *All prices are quoted in AUD\$ and are exclusive of GST*

STALLHOLDER INFORMATION

- *Stallholders are to present stands and staffing to a high standard. It is the responsibility of the stallholder to ensure marquees are securely weighted.*
- *Stallholders/Vendors are responsible for the disposal of all waste materials in an appropriate manner. All packaging and product waste is to be removed from the event area by stallholder.*
- *Stallholders are required to supply their own lighting. Any lighting must be as per the Equipment Declaration.*
- *Stalls must not be pulled down prior to 4.00pm. (if sold out stalls can be tied up/closed ready for pull down)*
- *The stallholder agrees to indemnify the organizing committee, Goomeri Pumpkin Festival Inc, against all liability, claims, demands, expenses, fees, fines, penalties, suits, proceedings and actions of any kind.*
- *The stallholder occupies and uses the site at their own risk, indemnifying the organizing committee and the Goomeri Pumpkin Festival Inc from any liability for any damage to the display, stall or any other property of any description, or eviction due to non-coherence to safety regulations.*
- *There is **no parking** in the main streets or on bypass roads on festival day.*
- *Vehicle access:*

Bump in – Sunday Festival Day – Any time from 5.30am up till 8.00am. All vehicles must be clear of site by 8.00am

Bump out- Sunday Festival Day – After 4pm, Please be patient and aware of other vendors and their vehicles

- *A copy of current public liability/product liability and all appropriate food licences must accompany all application forms.*

Operators of electrical or gas equipment/leads MUST read and Agree

- All electrical cables that cross pathways/lawns must be covered by cable covers and be safely secured.
- The following information is mandatory: -
 1. Test & Tag: All equipment must display a current electrical tag. The information must be up to date and include the following: Tag number, Test date, Test date due.
 2. Watts/Amps: On every piece of equipment a compliance plate will be visible.

3. Under the Fire Safety Regulation, where a stall uses a gas or electrical appliance to cook or heat food, it is required to have a fire extinguisher for that type of fire and where a stall uses oils or fats it is required to have a fire blanket. All extinguishers and fire blankets must have an inspection tag attached.
4. All gas equipment must comply with relevant Australian Standards and non-portable gas appliances fitted by a registered gas fitter. You are required to ensure that all gas appliances have been approved and display a Certification badge.
5. The test date on gas cylinders to be not more than 10 years.

Cancellation and Refund Policy

1. All cancellations must be received in writing.
2. Cancellations received prior to March 31st will attract a refund less administration fee of \$50.00
3. Cancellations received after 31st March will result in a NIL refund.
4. The Goomeri Pumpkin Festival Inc. will not be liable for any loss incurred by a stallholder or for the refund of any fees if the event does not proceed for any or all of the program due to inclement weather or any other factor beyond the control of the Goomeri pumpkin Festival Inc.
